The East Hartford Housing Authority ("Authority") will receive sealed bids from contractors for SITE UPGRADES AT ROCHAMBEAU APARTMENTS, East Hartford, Connecticut. This project generally consists of bituminous pavement repair, re-stripping, catch basin work, concrete sidewalk work, tree and stump work, limited survey work and minor regrading. The bids will be separated as listed in the bidding documents. In the best interest of the East Hartford Housing Authority (EHHA) will have the right not to accept any of the bids or the right to accept all or a portion of the bid. The Bid shall be broken out as listed in page 1 of 4 in the Bidding Documents, and section 01270 unit prices.

Any bidder in attendance of this meeting will be held responsible for understanding the extent of the work and the contract requirements. The last day all questions to be answered will be **Friday August 14, 2020**

Bids will be received at the main office of the Authority until **2:00 p.m. on Thursday, August 20, 2020** and publicly opened. Bids shall be accompanied by a five percent (5%) bid bond. This project is subject to State and Federal Law. Please be sure to label the Bid Alternate 3 Rochambeau site work as noted in the bid documents, section 01270, page 2 of 2.
